### THE NEW MASTER

We were very fortunate in the final quarter of Past Master Dancaster's year to admit so many new Freeman and Liverymen to our number. I hope the drive for membership under the Junior Warden Karl Davies will continue and we will assimilate the newcomers into our ranks and welcome each and every one of them. I have asked Jonathan Tecks to take on a role of liaising more closely with university and post-graduate educational establishments offering higher educational courses in Alternative Dispute Resolution and Arbitration so that we can foster future generations of upcoming Arbitrators and do what we can to promote the craft and art of Arbitration.

I hope the programme set out on the website and in circulars from the Clerk is going to prove one that gives the Company a lot of time to get to know each other better and to enjoy visits to alternative Courts within the United Kingdom jurisdiction. I also want the Company to focus on its charitable work and get closer to its key functions in support for the Lord Mayor and the City of London.

I am also very eager to support the Lord Mayor and the City of London in all his endeavours. You will be pleased to know that the company has sent £250.00 to the Lord Mayor's Charity "Bear Necessities" for which we have the undoubted privilege of having an Arbitrator teddy bear hanging on the Mansion House Christmas tree within an Arbitrators knitted jumper for the duration. The bear will very shortly thereafter be joining the Lord Mayor in his Venetian parlour to observe all the events of the Lord Mayor's year. The Arbitrator Bear having accompanied the Lord Mayor – Michael Bear – the Arbitrator bear will then come back to the Company and perhaps be auctioned or used in some other way to raise funds for the Lord Mayor's charities RedR and Coram.

The theme of "The Bear" also ran through the Lord Mayor's Show which was supported by 21 Members and Friends of the Company from the stands opposite St Pauls. Past Master Dancaster and Junior Warden, Karl Davis and myself walked in excellent weather conditions and flew the company flag in the accompaniment of the Lord Mayor to his swearing in at the Royal Courts of Justice. The guests and Members of the Company had an excellent lunch at Plaisterers Hall and afterwards adjourned to the Thames for a fireworks display. If anyone has not yet been to the Lord Mayor's Show and taken part it is actually great fun and this year the floats were led by giant statues of Gog and Magog taking the City history back to its routes and the old statues that used to stand at the bottom of Ludgate Hill.

Before the Lord Mayor's Show, the Company supported St John's Ambulance and the Lord Mayor in the City at the start of Remembrance Week by planting a cross in the Garden of Remembrance at St Paul's Cathedral with other Livery Masters. The ground conditions were reminiscent of The Somme with traffic replacing gunfire but we had rain, mud and a proper respect for the gallant men and women who had served so well.

There was also an opportunity to attend the Silent Ceremony at which the Lord Mayor is admitted which took place on Friday, 12th November 2010 and the briefing of Masters at Mansion House on 23 November 2010.

The two other Company events in 2010 were the Carol Service at St Mary Le Bow followed by mince pies and wine on Monday 13 December 2010 and the trip to the Pantomime. Apart from the failure of the heating at St Mary Le Bow the service was its usual success with a wide-ranging address by our Chaplain and marvellous music from the newly refurbished organ on which our Arbitrator's Theme was played. The Arbitrator's Theme is a piece of music composed by Helen Jane Long who is an internationally recognized musician whose music mirrors the progress of an Arbitration reference from an initial referral, advice from lawyers to appoint an Arbitrator, the appointment, submissions, disclosure, an Oral Hearing and the Final Award. The Arbitrator's Theme is available as one piece on a CD of Helen's music which is available from the Master as Helen has kindly agreed to donate the proceeds to our Company charitable Trust. Forms to order CDs will be circulated by the Clerk after the New Year

I would like to take this opportunity in my first letter to remind Members of our ongoing financial commitment to supporting the Charitable Trust which is there to promote our art, craft, students and causes in support of the City of London. I have been persuaded by various other companies and Livery Events that I have attended in the short time that I have been Master that it is normal that every Liveryman accept there is a minimum donation of at least £120.00 plus gift aid per annum and I would encourage all those who have not signed a gift aid form to contact Assistant Michael Goodridge and make sure this is set up together with a standing order or direct debit form. These are obtainable from him and his details follow in a separate short article.

The final event in 2010 will be a trip to Brick Lane Music Hall for "Mother Goosed". This is an Adult Pantomime and it should be great fun. Brick Lane Music Hall is run by a troop of actors and it is also a charity that retains all the profits (apart from the actor's drawings to cover board and lodgings) to cover their charitable work in respect of providing entertainment to the elderly. The evening is great fun but I have only managed to secure some 40 tickets so places are very limited, at the time of writing there are just a few left.

I am looking forward to seeing as many of you as possible in the programme during the year ahead and I particularly hope that you will support the Mansion House Banquet which is indeed a very special occasion for this Company. I would also like every Member of the Company to get more involved in events and ideas and I would welcome emails from any of you if you have any burning issue in the year ahead.

## THE CHARITABLE TRUST

The object of the Worshipful Company of Arbitrators' Charity Fund is to provide financial support to the charitable activities connected with Dispute Resolution and the City of London. The Trustees meet regularly to agree grants and to approve one off grants to suitable beneficiaries. The Trustees are a separate entity and have limited assets to deal with everything that comes before them. Members gift aid donation including tax recovery are the prime source of income and the balance comes from investments and other donations and the occasional fund raising event such as the Summer Concert. The Trustees are striving to increase the capital base to over £750,000 in the longer term. We would very much appreciate you remembering the fund in your Will. May we suggest that legacies either large or small are a way of saying thank you for all the pleasure and fun we have had together in the Arbitrators Company?

Liverymen are expected to donate annual minimum contribution to the fund and this recommended level is reviewed every year by the Trustees and Court in the light of inflation. For the current year it is suggested that the minimum should be £120.00 for Liverymen and Freeman are encouraged to give as generously as they can.

All U.K. Taxpayers using a personal account are requested to make payments by standing order and complete one gift aid declaration which will cover all payments. This enables the fund to properly account for monies received and provide adequate evidence in support of its tax free payment claim. We are also pleased to receive donations via the Charities Aid Foundation and from private Charities.
